UMPIRE HONORARIUMS FOR SEASON 2026-27

1. PENNANT (Two-Day & One-Day)/SUNDAY COMPETITION & UNDER 18 GAMES:

Panel Umpire – A flat rate of \$200 per day, irrespective of starting time.

NOTE: If only one umpire in attendance and officiates at both ends, \$225 per day.

Club Umpire - One end - \$180 per day. Club Umpire - Both ends \$205 per day.

2. PENNANT GAMES (T20):

Panel & Club Umpires – A flat rate of \$105 per day.

NOTE: If only one umpire in attendance and officiates at both ends, \$120 per day.

For games abandoned at grounds \$70.

3. FINALS and REPRESENTATIVE GAMES:

Flat rate of \$220 per day, irrespective of starting times.

4. T20 TWILIGHT GAMES:

Preliminary Rounds \$90 per game. Semi-Finals & Final \$100 per game.

5. JG CRAIG (Under 15) GAMES:

Rounds 1-7 & Quarter Finals \$165.

Only 1 umpire in attendance \$190.

Semi-Finals & Final \$185.

For games abandoned at ground \$70.

All Honorariums to be paid by the VSDCA Board.
